Engine 1 responded to 15621 Marine Drive for report of Alarms ringing. Once on scene Command was established with nothing showing, bystander stated s.22 had activated a pull station. Before entering the building the crew noticed a s.22 laying on the stairs of the main entrance with multiple small lacerations. One member of the crew began to assess the patient and command continued to the alarm panel. Panel indicated 3rd floor general alarm, crew investigated and confirmed a false alarm. Dispatch and all units were updated, panel was reset. Patient stated that s.22 4 cats had clawed and bitten s.22 while trying to evacuate the building. Auxiliary 410 pagers were sounded for routine response due to long BCAS wait times, Squad 1 took over for engine 1. BCAS arrived shortly afterwards and transported the patient to PAH for further evaluation, Squad 1 cleared the call.

Exposure to Blood

During the call Fire Fighter Watson was grabbed by the patient on the forearm resulting in the patient transferring blood onto Fire Fighter Watson. Exposure to blood was noted in FDM drop down box and Duty Chief Passas was notified and will be following up.
