- an error or omission respecting the taxable frontage of a parcel; and
- an exemption has been improperly allowed or disallowed.

Those property owners affected have been notified by mail.

A complaint shall not be heard by the Parcel Tax Roll Review Panel unless written notice of the complaint has been made to the office of Sandra Kurylo, Director of Financial Services, at least 48 hours prior to the time set for the sitting of the Parcel Tax Review Panel on April 26, 2016 at 1:00 p.m.
