The City of White Rock has received an application to change the Official Community Plan designation on the subject property from ‘Multi-Unit Residential (Low Density)’ to ‘Multi-Unit Residential (Medium Density)’, and rezoning the property from ‘RS-1 One Unit Residential Zone’ to ‘CD-59 Comprehensive Development Zone’. If approved, this will allow a five-storey, eight-unit residential development with one-and-a-half levels of underground parking. A Major Development Permit is required for the form and character of the development.
