#### **ADVANCE ELECTOR REGISTRATION**

Are you eligible to vote at the November 15, 2014 elections for the Corporation of the City of White Rock? Is your name on the current list of electors?

If you are not sure you can find out by calling 604.541.2212 or 604.541.2129 or visiting the Corporation of the City of White Rock office at 15322 Buena Vista Avenue, White Rock, BC. Office hours are 8:30 a.m. to 4:30 p.m., Monday to Friday (excluding holidays).

Advance elector registrations will be accepted at the Corporation of the City of White Rock office until September 23, 2014. With the exception of registrations on voting days, elector registrations will not be accepted during the period September 24, 2014 – November 17, 2014.

#### **ELECTOR QUALIFICATIONS**

#### **Resident Electors:**

- 18 years of age or older on general voting day; and
- a Canadian citizen; and
- a resident of British Columbia for at least 6 months immediately before the day of registration; and
- a resident of the Corporation of the City of White Rock for at least 30 days immediately before the day of registration; and
- not disqualified under the *Local Government Act* or by any other enactment from voting in an election or be otherwise disqualified by law.

#### **Non-Resident Property Electors:**

- 18 years of age or older on general voting day; and
- a Canadian citizen; and
- a resident of British Columbia for at least 6 months immediately before the day of registration; and
- a registered owner of real property in the Corporation of the City of White Rock for at least 30 days immediately before the day of registration; and
- not entitled to register as a resident elector; and
- not disqualified under the *Local Government Act* or by any other enactment from voting in an election or be otherwise disqualified by law; and
- if there is more than one registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non-resident property elector.

#### LIST OF REGISTERED ELECTORS

Beginning September 30, 2014 until the close of general voting for the election on November 15, 2014, a copy of the list of registered electors will be available for public inspection, at the Corporation of the City of White Rock Administration office at 15322 Buena Vista Avenue, White Rock, BC, during regular office hours, Monday to Friday, excluding statutory holidays. Before inspecting the list, a person must sign a statement that they will not inspect the list or use the information included in the list except for the purposes of Part 3 – Electors and Elections of the *Local Government Act*. An elector may request that their address or other information about them be omitted from or obscured on the list of electors.

#### OBJECTION TO REGISTRATION OF AN ELECTOR

An objection to the registration of a person whose name appears on the list of registered electors may be made in accordance with the *Local Government Act* until 4:00 p.m. on October 10, 2014. An objection must be in writing and may only be made by a person entitled to be registered as an elector of the Corporation of the City of White Rock and can only be made on the basis that a person whose name appears on the list of electors has died or is not qualified to be registered as an elector of the Corporation of the City of White Rock.
