- an exemption that has been improperly allowed or disallowed.

A complaint shall not be heard by the Parcel Tax Roll Review Panel unless notice of the complaint has been made to the office of Ms. Sandra Kurylo, Director of Financial Services, at least 48 hours prior to the sitting of the Parcel Tax Roll Review Panel on April 25, 2013.
