- *All communications (whether by letter, email, text or other messaging platform and whether the communication occurred internally or was sent to or received from third parties), applications, council meeting agendas and minutes, council meeting submissions, notes, plans, invoices, agreements and other records relating to the installation of the rainbow crosswalk at the intersection of Johnston Road, Buena Vista Avenue and Pacific Avenue.*

I have done some investigation regarding this request.

The options below are for a standard crosswalk, if the decision is made to make it look artistic that will drive the price up.

We have two options:

1. \$7000 for MMA (Methyl Methacrylate) – which is the premium thermoplastic that will last longer
2. \$20000 for concrete

I have attached a picture of the crosswalk that Maple Ridge installed and this is where I received the information from.

MMA would be the way to go as concrete is overkill.

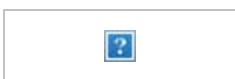

A rainbow of colours will be painted in front of Hamilton city hall.

The city's public works committee agreed to install rainbow crosswalks at four locations at Main Street West and Summers Lane in two directions and at Stirling Street and Forsyth Avenue in two directions, located in Ward 1, near McMaster University. The location was requested by Ward 1 Coun. Aidan Johnson.

"This very much speaks to diversity and inclusion," said Hamilton Mayor Fred Eisenberger, who introduced the motion at the June 18 meeting.

"We believe Hamilton is for all people," said Eisenberger, pointing out June is Gay Pride Month. "We can reflect that with some colour on one of the most important intersections in the city."

The rainbow crosswalk is a symbol of inclusiveness among the LGBTQ community.

The Main Street West and Summers Lane crosswalk is located across from city hall.

Eisenberger said people have been flocking to Hamilton city hall's forecourt recently since the unveiling of the "Hamilton" sign and the new floral sculpture of "Jasmine" the butterfly and "Ralph" a puppy, who is eyeing a tennis ball.

"We have made some nice investments in our city hall forecourt," said Eisenberger. "People are seeing their city hall in a different light."

The proposed cost is about \$6,000 per location. The funds will be taken from the city's reserve fund.

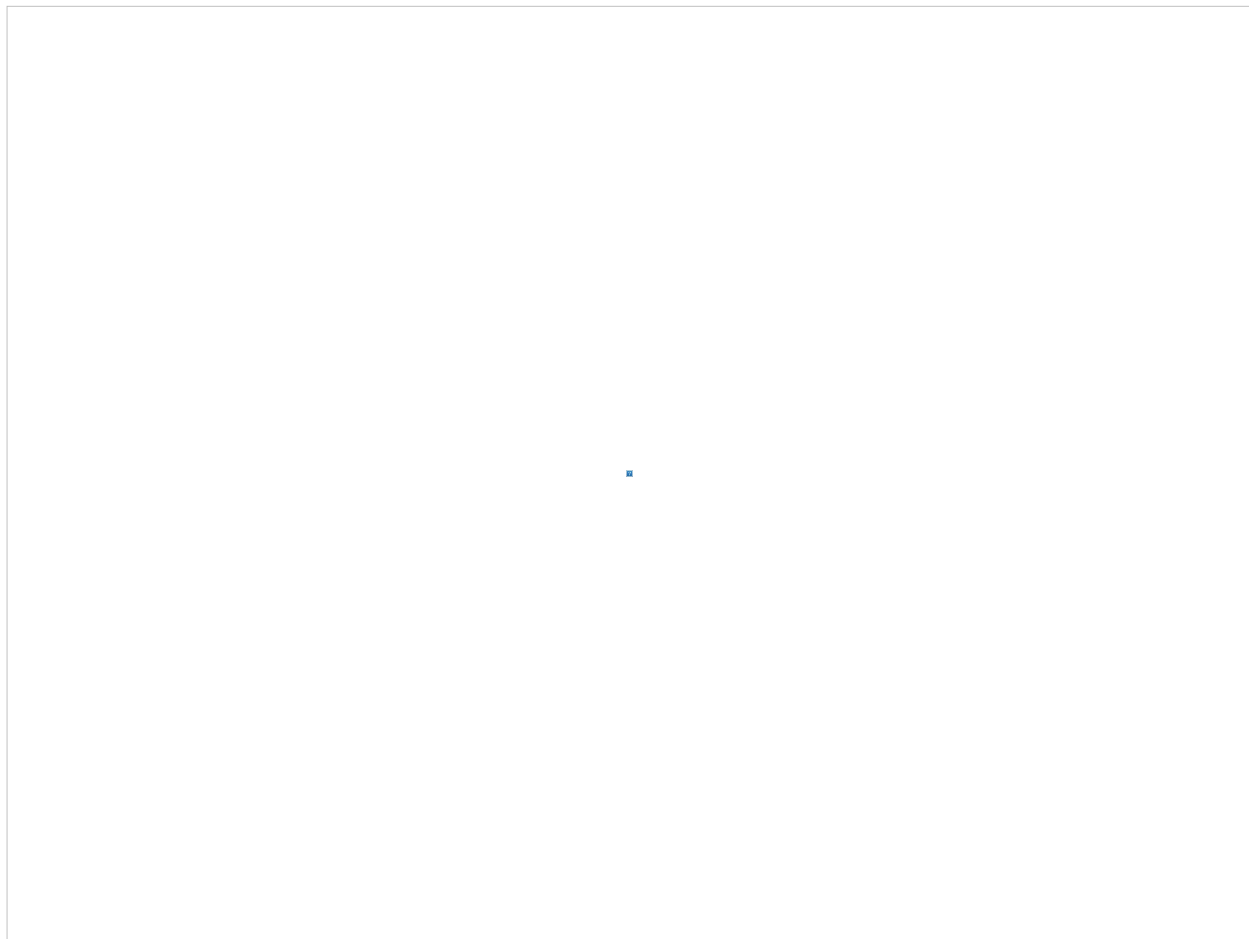

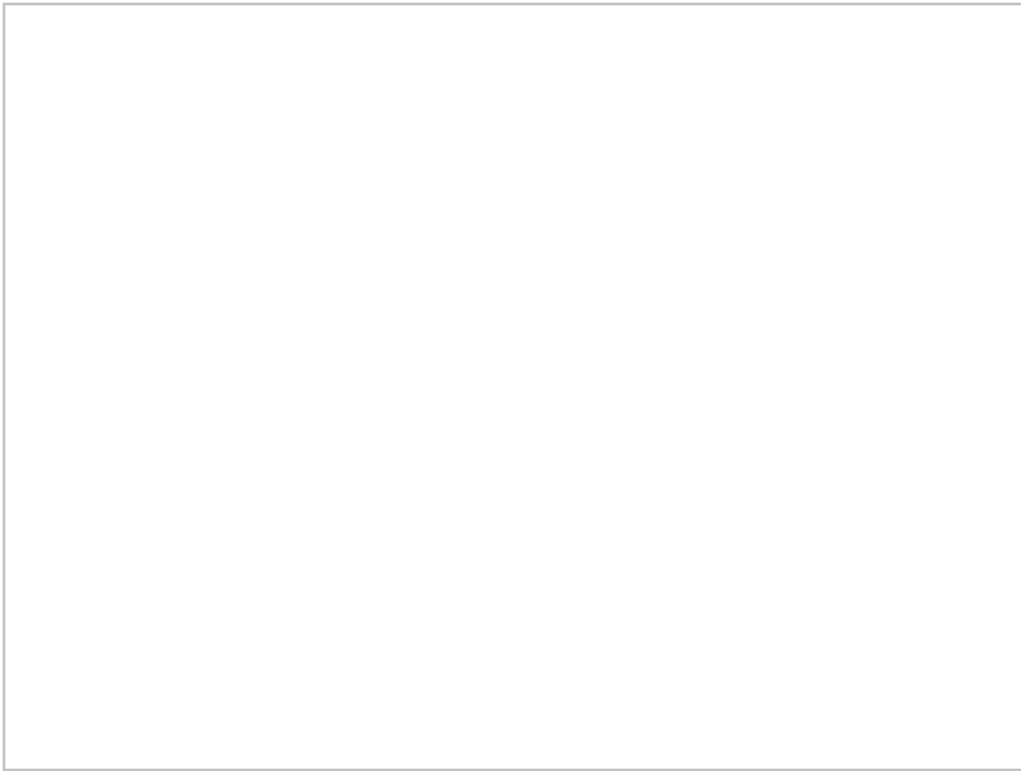

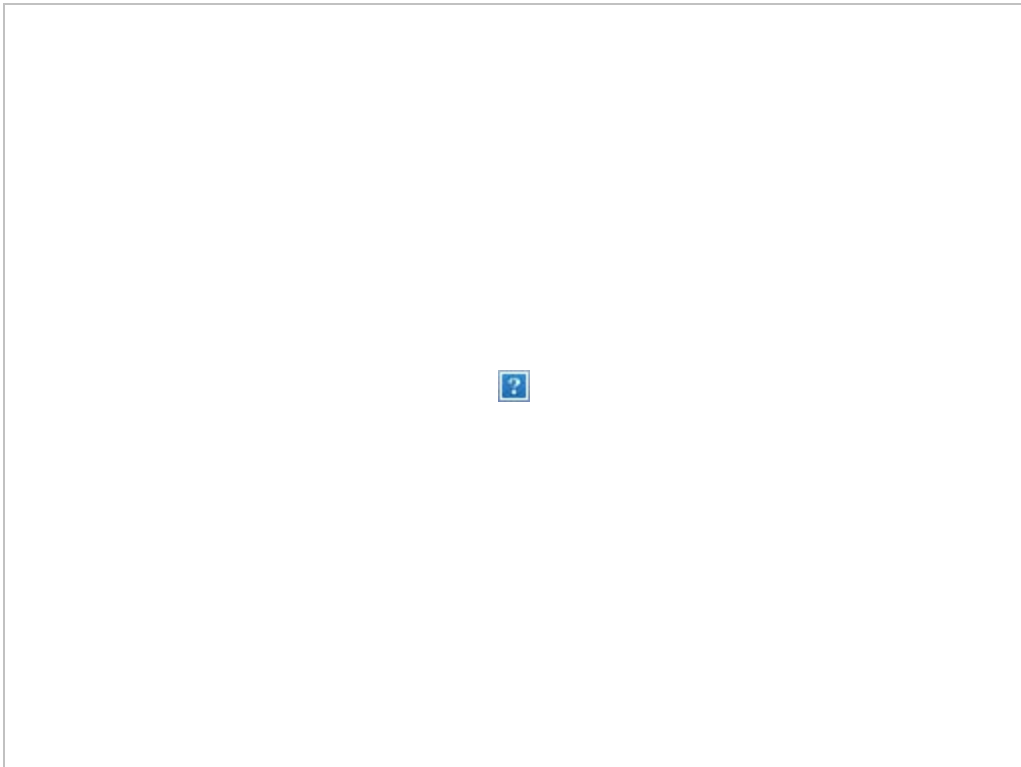

Hi Jim,

I like the idea of crosswalk art, ie. something along the lines of thermoplastic from HUB (<https://hubss.com>) or similar could work.

The mid-block crosswalk would be a good candidate in the short term, as the natural narrow point in the new street segment will highlight any design that is placed there; perhaps something that reflects the adjacent theatre/cultural corridor idea.

The North Bluff crosswalk may be something that requires a little bit more time to contemplate vis a vis the Gateway Feature, the public art plan and perhaps coordination with Surrey.

In terms of process, and beyond the ultimate decision by Council, a public art call through the PAAC is the most comprehensive approach, provided clear design/feasibility parameters are communicated to artists. However, this will take months to complete and the installation would occur in 2019.

A RFP call/consultant design may be quicker but would likely still require a review/decision by a Committee/body and the timing will likely be beyond October. Another option is looking at off-the-shelf designs from HUB that relate to the Johnston Road project, the adjacent uses (ie. Coast Capital) or corporate branding (ie. City waves or other elements reflective of WR's physical context), and see what Council thinks of some design options on Sept 17.

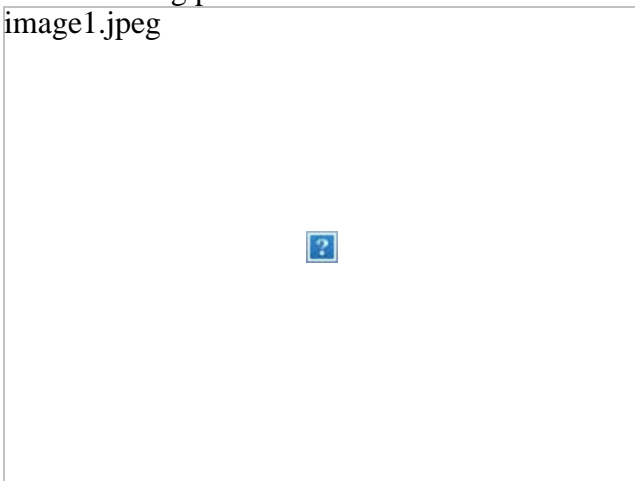

- (b) to promote a climate of understanding and mutual respect where all are equal in dignity and rights;
- (c) to prevent discrimination prohibited by this Code;

By allowing the privileged politicization of a crosswalk to members of an identifiable group, namely LGBTQ in Surrey, you are violating Sec 3 (b) of the Code and failing to treat other groups equally. Are you willing to dedicate crosswalks to Muslims, Christians, or groups who are prolife? How about other political groups? The Communist Party, NDP, Christian Heritage Party...?

As a country we are being burdened and overwhelmed with the thoughtlessness of minority groups making their demands, without any consideration to the costs associated, and paid for, by their fellow Canadians and unfortunately politicians have become so concerned about political correctness that common sense has taken second place. This is no longer going to bring unity and feelings of inclusivity, but rather anger and resentment is growing... and rightfully so. I respect an individual's rights to live as they please but when that impedes on my rights and my pocket book, I draw the line. I, also, strongly believe that, on a moral ground, based on the evidence provided, we have a duty and an obligation to protect society further from this conspiracy

My question, and that of every Surrey Taxpayer, is...why was this done behind obvious closed doors and so deceptively?

Dear Honourable Claire Trevena, Minister of Transportation and Infrastructure,
