Re: Request for Records
Freedom of Information and Protection of Privacy Act

The City of White Rock has processed your request for access to the following information pursuant to the *Freedom of Information and Protection of Privacy Act (the Act)*:

- 1) *all emails, correspondence, text messages, invoices and purchase orders (for removal) , arborists reports and other reports (the dangerous situation the trees were causing or regarding view blockages) on the two trees that were cut down at 1235 Oxford Street on June 13th, 2019*
- 2) *a copy of a City variance, permission letter or other to allow the owner to landscape, plant and grow shrubs and flowers as well erect sidewalks and pathways on the City Owned land surrounding these trees from the corner of the North intersection to the City barrier South of the trees.*

Access is available to the records responsive to item 1). However, some of these records contain information that is excepted from disclosure under the Act. I have severed the excepted information so that I could disclose to you the remaining information as attached.

The severed information is excepted from disclosure under sections 22 and 21 of the Act. Severing under 22 was necessary in order to avoid disclosing any third-party personal information without permission. Severing under section 21 is necessary to avoid harming the financial interests of a third party. All third-party billing rates have been severed.

NOTICE TO LOCAL AREA RESIDENTS WITHIN WORK ZONE McDONALD Ave & OXFORD ST.

On Thursday, June 13th, 2019, our Hazard Tree Removal crews in conjunction with the City of White Rock will begin the removal process on (2) large dead Douglas fir trees located on City property adjacent 1235 Oxford St. To ensure public safety and ensure the safety of all workers, temporary road closures and driveway access restrictions will be implemented. The City and our staff have taken every step to ensure the process has as little impact as possible and made sure the job will only take one day.

Construction noise and temporary traffic delays can be expected during regular working hours on this day. Traffic control personnel will be onsite to assist traffic through the construction zones.

THE FOLLOWING HOMES WILL HAVE DRIVEWAY ACCESS CLOSED BETWEEN 7:00AM-5:00PM.

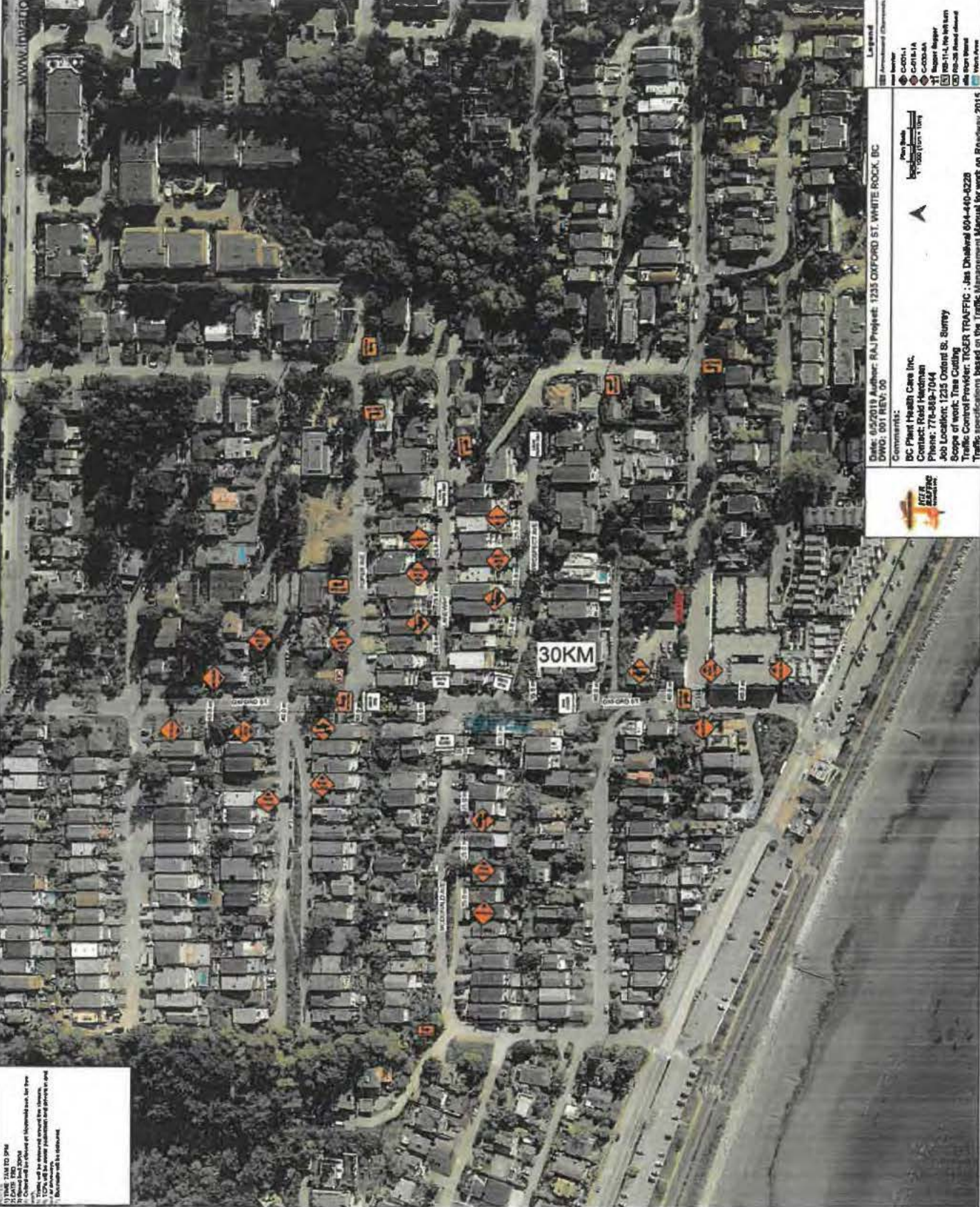

A. PERMISSION IS HEREBY GRANTED TO: BC Plant Healthcare Inc

To do the following work at the above location:

- Remove two trees from City boulevard adjacent to 1235 Oxford Street.
- Perform a full road closure along Oxford Street as per the attached traffic management plan date stamped received June 7, 2019.
- The contractor must notify the Operations Center – 604-541-2181 - to alert of the road closure a minimum 3 business days in advance. No driveways are permitted to be permanently blocked as a result of the closures.
- The contractor must distribute construction notices to affected businesses and residents a minimum 3 business days in advance of the road closure
- **All restoration works and sidewalk cuts to conform to MMCD standards and to the satisfaction of the Director of Engineering and Municipal Operations.**
- Traffic control, signage and flag persons must be in place for the duration of the closures while works, people and equipment are on the road and right of way.
- Any alterations or improvements on the City Boulevard must first be approved by the Engineering Department.
- The owner/contractor is responsible for the repair of any damage to the road and right of way as a result of the works.

B. COMPLETION REQUIREMENTS

- A charge of \$250.00 shall be charged for each additional inspection, and deducted from the security amount provided.

- All Works are to be completed to the satisfaction of the Director of Engineering and Municipal Operations

C. CONDITIONS OF PERMIT

- I hereby agree to abide by all the terms of this permit and the City's Street and Traffic By-law which pertain to this permit.
- I have deposited as security the amount of \$0.00 (*On behalf of the City of White Rock*) with the City to guarantee the fulfillment of the conditions and completion requirements of this permit and of the Work within the time specified for the permit.
- I understand the City will return the security upon completion of a one year maintenance period, from the date of the acceptance the Works by the City, and if required a submission and acceptance of any as-built drawing minus any costs incurred by the City for inspections, rectifying the Work, or damage to City property.

- The Prime Contractor must have a valid City of White Rock business license.
- All works shall be completed in accordance with all current Corporation of the City of White Rock construction specifications and standard drawings. The Prime Contractor shall not employ or sub-contract with any party not skilled in the work assigned. As-built drawing may be required with the attached specifications prior to release of security. Hello Steve,

I have sent out a request for a priority TMP, they will be putting this together for us asap. Once this is done, I will be sending it to you, or in this case, I will cc all to make sure it gets to the correct person. Your traffic department and emergency services will want this as it will include all required road closures. I have the crane company looking at the requirements as well to confirm our plan. With exception to the overall inconvenience of the road closure, it appears we will have (4) driveways impacted with full access restrictions for vehicles. We will need to speak with these people prior to make sure vehicles are moved. There is no restrictions for foot access. As soon as I have these sites confirmed, I will pass it along. 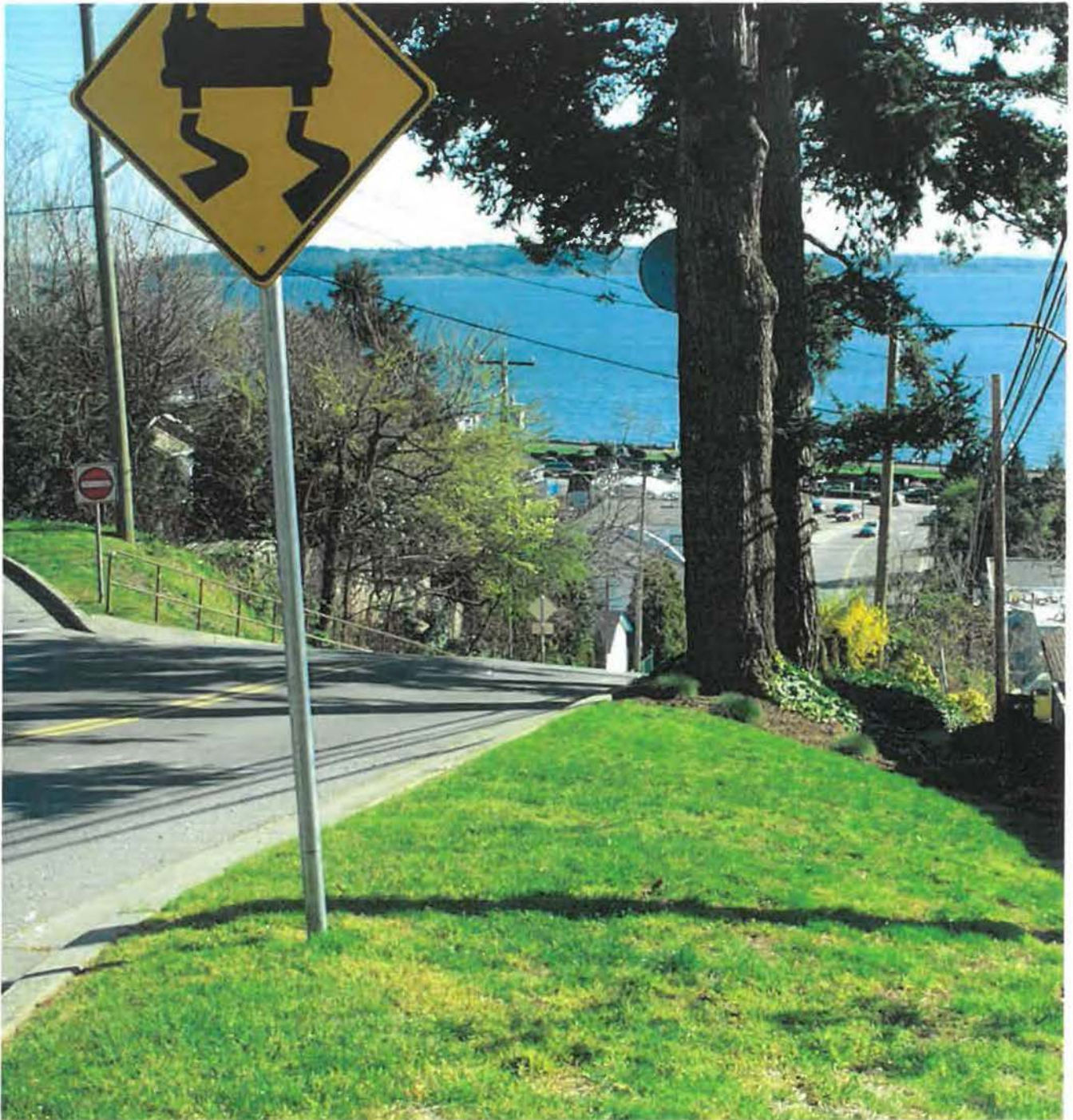

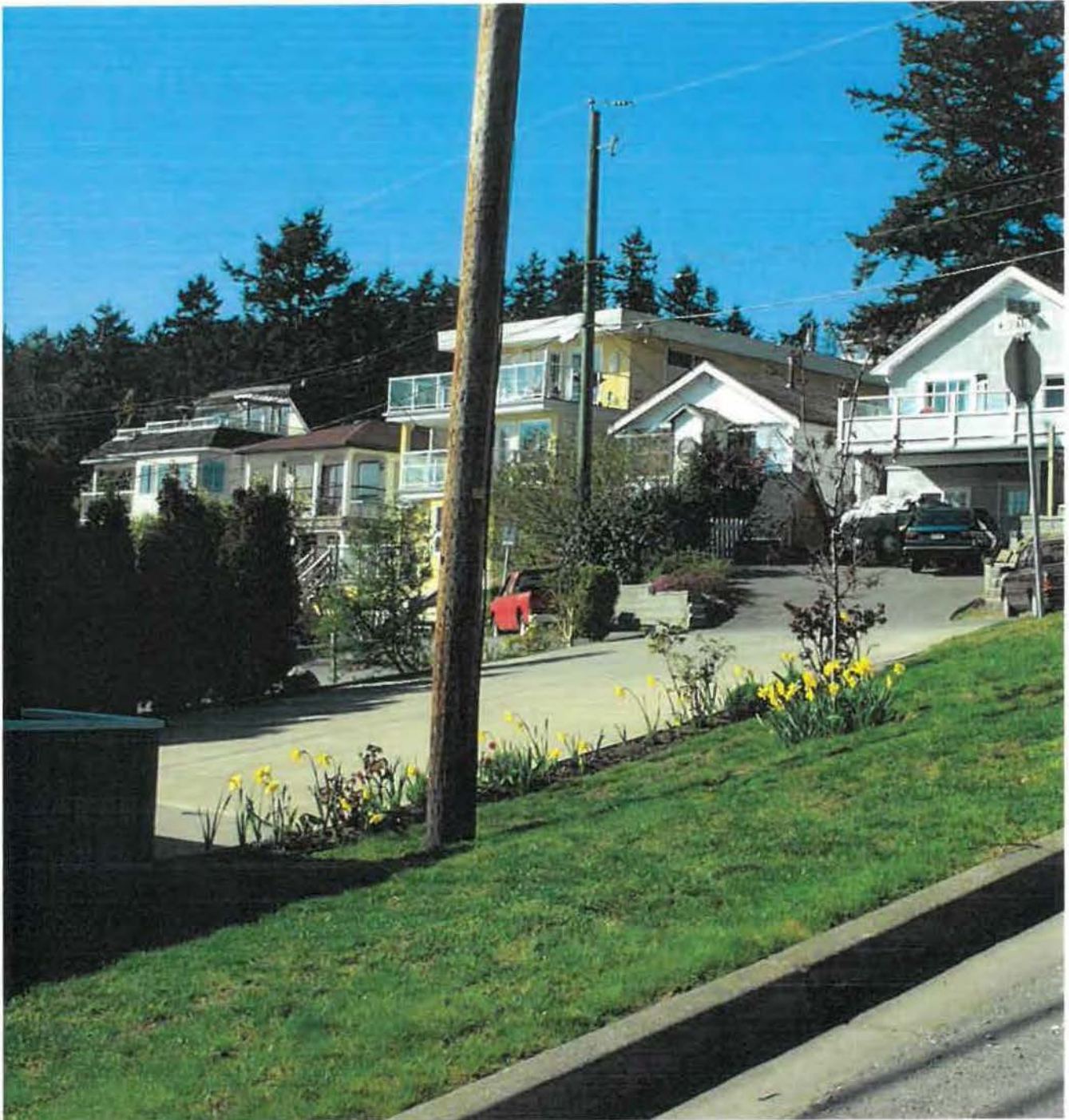
