#### **RE: APOLOGY / CENSURES OF COUNCILLOR CHESNEY**

This is a formal letter of apology that White Rock City Council have endorsed be issued to Councillor David Chesney.

It was brought to Council's attention that Councillor Chesney was censured twice by the previous Council during the 2014 – 2018 Council term.

- March 2, 2015: Subject of Censure: Council believes that Councillor Chesney has acted in a manner unbecoming a member of City Council and not in accordance with City Policy – Respectful Workplace Policy 405
- October 24, 2016: Subject Censure: Breach of confidentiality in regard to the City's legal relationship with the Semiahmoo First Nation where the City currently is negotiating reserve servicing matters

Following a review of the documentation regarding the censures, Council adopted the following resolution:

THAT Council endorses an apology with all details in regard to payment of funds for Deputy Mayor and Legal expenses if applicable as they hereby rescind the resolutions of the previous Council (2014-2018 term) that censured Councillor Chesney.

Council further authorized:

1) Reimbursement for monies lost for four (4) years for the 2014 – 2018 Council term that would have been paid to Councillor Chesney for the role of Deputy Mayor.

2) Reimbursement for legal fees that Councillor Chesney paid to defend himself in regard to the censure(s) in the amount of \$1,097.60.

The documentation was also reviewed by the City's solicitor to ensure any release of information was done in accordance with the legislation.

FURTHER THAT Councillor Chesney be removed from all Committees of Council, exterior representations, and Acting Mayor duties until January 1, 2016.





Every document that Council might consider in relation to the motion was provided to Councillor Chesney along with the notice. Council members must keep an open mind during this hearing.

Councillor Chesney made a statement, notes were not provided to staff.

A cursory summary of the statement included the following:

- Apologized, if I could do it over I would have handled things differently
- The e-mail that Councillor Joanne Charles, Semiahmoo First Nation (SFN) was included on, Council must take into consideration the severity of what was actually said

- The dealings staff had with SFN should have been done in person / this was not adhered to as it was discussed by Council, was trying to smooth over the actions as Councillor Charles was upset by the letter sent from the City
- Again if I had to do this again I would have taken another action and I apologize for the action that was taken
- When the SFN media release was seen, I was shocked
- Sent 3 4 e-mails to the Chief Administrative Officer following a chance meeting with Councillor Charles where I was told the March 2016 meeting between the Councils was not satisfactory
- Seeing there were two (2) versions of what occurred at the March 2016 meeting I thought a further meeting between the two (2) Councils would be beneficial and so I sent the e-mail and included Councillor Charles in the e-mail hoping that it would bring SFN back to the table
- My motivation was to bring both Councils back together so we can work to solve the matter

Council at this time had the opportunity to ask questions.

Discussion included:

- This is not the first time confidential information has been released by Councillor Chesney, earlier this year he admitted to another member of Council that he had had a conversation with a SFN member following discussion held in a closed meeting
- Concern Councillor Chesney took it upon himself to get involved individually in the matter when staff and the City Solicitor were working on a solution including negotiations

- 1. That Council shall address what it believes to be a breach of confidentiality in regard to the City's legal relationship with the Semiahmoo First Notion, where the City currently is negotiating reserve servicing matters by way of:
  - (a) a motion of censure;
  - (b) public notification of sanctions.
- 2. That the Corporate Officer be directed to publish a media release containing the information concerning this matter that may be released in keeping with the District's obligations pursuant to the *Freedom of Information and Protection of Privacy Act*, substantially with the content of the following:

"WHEREAS within the City of White Rock's Council and Committee Procedure Bylaw there is a provision in regard to a motion to censure that may be used to express Council's indignation with a Council member's conduct regarding Council business;

## THEREFORE BE IT RESOLVED ..."

## It was MOVED and SECONDED

THAT Council hereby formally:

- (a) censures Councillor Chesney for Breach of confidentiality in regard to the City's legal relationship with the Semiahmoo First Nation, where the City currently is negotiating reserve servicing matters;
- (b) removes Councillor Chesney from the Deputy Mayor rotation, for the remainder of the current Council term;
- (c) cancels City funding for Councillor Chesney to attend Union of British Columbia Municipalities (UBCM), Federation of Canadian Municipalities (FCM) and Lower Mainland Local Government Association (LGLMA) conferences / conventions / meetings, for the remainder of the current Council term;
- (d) cancels Councillor Chesney's utilization of the Council Expenses authorized under Council Policy 106 Council Remuneration und Expenses (Discretional & Educational Conferences) & annual reimbursement to cover expenses for attending and representing the City of White Rock, as individual Councillors, at local community events, for the remainder of the current Council term;
- (e) shall review the conduct of Councillor Chesney to ascertain whether his conduct results in financial loss to the City in relation to the negotiations re: servicing the Semiahmoo Reserve;
- (2) Directs staff to bring forward an amendment to the Council and Committee Procedure Bylaw to create an offence where any Breach of Confidentiality by a Council member occurs, such that a contravention of the bylaw provision may result in a statutory injunction and ultimately contempt of court proceedings in the event of continuing contravention.

## Council debated the motion

Question was called on the motion with the clarification that items c) and d) were for the remainder of the Council term and the motion was

<u>CARRIED</u> Councillor Fathers and Mayor Baldwin voted in the negative

#### <u>Subsequent Motion</u> It was MOVED and SECONDED

THAT Council authorizes the release of information regarding the censure as follows:

- Councillor Chesney has been censured a second time.
- Following a process in accordance with Procedural Fairness City Council determined that Councillor Chesney has breached trust and has shared confidential information that may result in impeding of closed negotiations.

- The result of the censure removes Councillor Chesney from the Deputy Mayor rotation for the remainder of the current Council term.
- The public will be notified of the censure through a media release, the draft media release was provided on table, and the information will be stated at the October 24, 2016 regular Council meeting, that a media release will be issued regarding the censure.

## **CARRIED**

The Chairperson called a recess at 4:41 p.m.

The meeting was reconvened at 4:50 p.m. with all noted members of Council, City staff and P. Hildebrand, City Solicitor, in attendance.

The Chairperson informed Councillor Chesney the motion of censure was endorsed and clarification was made that items c) and d) also were for the remainder of the Council term.

And further stated to Councillor Chesney the importance of working with Council, not alone and of operating within the legislation. The negotiations underway with the SFN involved millions of dollars and we are all concerned this act has compromised or will compromise the City's position.

Each member of Council has noted they are very concerned with the lack of trust they feel.

Councillor Chesney was given the opportunity to respond and stated he did not feel this was a team environment.

Mr. Hildebrand, City Solicitor, departed the meeting at 4:57 p.m.

Any person who is elected or appointed to office, on a municipal council, must make an oath or solemn affirmation of office, under section 120 of the *Community Charter* and are bound by duty to section 117 of the *Community Charter* to respect confidentiality. Regrettably, City of White Rock Council has lost faith and trust in Councillor David Chesney's ability to respect and uphold the integrity of the members' office and oath.
