He's interacted with them hundreds of times. He was very well aware of what to expect from them when he "VOLUNTEERED" to come into my unit knowing I have the dogs and their behaviour.

The only reason why I invited **s. 22** to come into my unit to investigate the sound was because I was instructed to do so by you otherwise I would not have invited him in.

## Hi Redacted S. 22

This is my response to the complaint.

1) Alleged Dog Bite - My dog Chewy did not bite **s. 22** . **s. 22** came to my unit and I was holding one dog in my arms. **s. 22** was wearing short pants and Chewy as he does with all visitors was excited and jumped up on **s. 22** 's legs just to say hello and to get his attention. Chewy is the really sweet and friendly. The dogs the same thing to me when I come home to greet me, and then they go sit down to receive a treat. It was not an attack as **s. 22** is describing. He is exaggerating and overreacting. Chewy had a dog grooming appointment that afternoon but it was cancelled because of the snow. His nails were a little long so all that happened was he scratched him.

I examined **s. 22** 's leg and he had several cuts and bruises. My dog did not puncture his skin. I looked at **s. 22** 's leg and rubbed it to see. There was a white mark from the scratch. If the skin was broken I would have disinfected it immediately. I asked **s. 22** if he was ok and he told me he was fine and everything was ok.

I was completely surprised when **s. 22** called me over an hour later. His attitude towards me changed and he was demanding that I show him the rabies vaccination forms which I did.

- When **s. 22** came to my unit a second time to see the vaccination forms he was overly excited and blowing everything out of proportion. I was so surprised. He was nice when he left and there was no problem. His wife who was hiding in the hallway had to ask him to calm down when she decided to reveal herself. I asked to look at the apparent "puncture" that was covered by the bandaid. The original white scratch was clearly agitated from **s. 22** rubbing it. **s. 22** was in my unit for a good 15 minutes. If his skin was punctured we would have seen the bleeding or redness on his skin. I checked **s. 22** 's leg before he left and he had no redness and no bleeding, and he said he was fine.
- s. 22 always walks around with shorts on. He is the maintenance man and is always getting little scratches and cuts. I saw previous injuries on his legs. There was no broken skin when s. 22 left my unit. If the skin was broken it was because he did it himself from rubbing and scratching it.

My father spoke to **s. 22** over the phone that afternoon and **s. 22** apologized to my father for getting overly excited and when my dad asked **s. 22** if he'd be filing a complaint **s. 22** said that he was not going to and everything was good between us. I asked my dad to call **s. 22** because after his reaction I was worried. **s. 22** 's daughters dog nips at people so I'm completely dumbfounded that he

would create an issue about this. His daughters dogs bark and nip at me but I just laugh. I've never created a big deal when the dog Nico nipped at me once when I tried petting him.

My dog Chewy the black one is super friendly. He does not have a history of biting. He lickes and kisses but he's never bitten. I was holding Vladimir my other dog. They've jumped on **s. 22** before and **s. 22** never responded this way. Just before **s. 22** came to my unit the restoration guy was playing with both my dogs. I'm honestly surprised that **s. 22** is reacting the way he. He's always been good with me and my dogs in the past.

I feel like **s. 22** is siding with **Redacted S. 22** is filing the complaint now because he was asked to as a retaliation against me. I'm being bullied and harassed by the Strata Council who are abusing their power.

My response to the other claim about me allegedly making banging noises. They are lying. They are making false accusations against me as they threatened to do. It's so childish.

For the past two mornings I'm waking up to the people upstairs stomping and kicking the floor directly above my unit on purpose resulting in me waking up in a stressful panicked state. They are triggering my PTSD and my hurting my health intentionally. They know how to abuse and work the system and they are council. I'm being harassed and tortured by **Redacted S. 22** and I hear them laughing when they are creating this disturbance on purpose. They are creating the disturbances upstairs that's so loud and obnoxious on purpose because they want me to react. They are trying to trap me. This is slander to falsely accuse people of doing things they are not.

I have been Redacted S. 22 family physician for over ten years.

Redacted S. 22 lives in a White Rock Condominium where he functions as a maintenance man. Several weeks ago, a tenant called s. 22 to come into their unit to investigate an offending pipe noise.

When was allowed to enter the unit, a small aggressive dog ran at him and bit him on the left lateral calf avulsing about a 1cm flap of skin and there was a visible tooth puncture.

I disinfected the wound however, it eventually became infected requiring an oral

antibiotic. Over the next two weeks the wound healed satisfactory but left a sensitive 1cm

This letter is to advise, after reviewing all relevant information regarding the incident that occurred on February 12, 2019, the City of White Rock ("the City") will not be classifying your dog as an aggressive dog.

Please be advised that the City's interest is the protection of the public and any complaints regarding attacks and/or possible aggressive behavior from pets must be taken seriously.

Should the City receive further complaints alleging your dog was involved in an incident in which it displayed any sort of aggressive behavior, the City may be deeming your dog aggressive in accordance with the Animal Control and Licensing Bylaw, 2012, No. 1959 ("the Bylaw")

Once a dog has been classified as an aggressive dog, there are conditions that an owner must follow in regards to how the dog is to be controlled on and off the property. There is also an increase to the license fee for a dog classified as aggressive and significant fines if the conditions set out by the bylaw are not being adhered to.
