Finding #3 – Site Plan showing Bylaw Infraction



Analysis

- 1. Parked vehicles on boulevard obstruct sightlines of resident exiting driveway. The driver's vision of the through/eastbound vehicles are blocked by the parked cars.
- 2. According to TAC (Transportation Association of Canada) the sight distance inadequacy results in unsafe movements for resident to exit her driveway.
- **3.** Parked vehicles in violation of several clauses in the City Street and Traffic Bylaw:

City of White Rock Street and Traffic Bylaw No.1529 Stopping and Parking

- 23. No person shall stop, stand or park a vehicle:
 - (i) on a landscape boulevard;
 - (t) in front or within 1 metre of a public or private driveway;
 - (u) within 10 metres of an intersection;

Recommendation

Staff recommends removal of two (2) parking spots on Victoria Avenue on City boulevard to improve safety.
