What is a family?

Family means those who live at the same address; family members of all ages, including those related by blood, marriage/common-law or adoption. Same address includes separate living areas in one house (e.g., grandparents, siblings, or two (2) related families, each of whom may occupy one floor of a multi-unit house are considered one family).

What is net income?

Net income means total combined income, before taxes, by all family members 19 years and older in Canada and abroad, contributing to the household's income and expenses. This includes income from: employment of all types (full and part-time, reported or not reported) all investments, pensions, child support payments, rental revenues, funds in trust, disability benefits (taxable or not) and all other sources.
