1. Recruitment Update in Planning and Development Services

Department: Planning and Development Services

Summary: The City has hired its first-ever Economic Development Officer, Carolyn Latzen, who starts in the part-time role on Sept. 28. She has extensive retail and business experience in leadership roles, currently teaching in the marketing program at a private college in Surrey. Carolyn has been an active volunteer on the City's Economic Development Advisory Committee and as chairperson of the City's Marine Drive Task Force.

In collaboration with the Planning and Development Services team, the White Rock BIA, South Surrey-White Rock Chamber of Commerce and Explore White Rock, Carolyn will help the City with supporting businesses through the COVID-19 pandemic and refreshing the City's 10-plus-year-old Economic Development Strategic Plan.

Bylaw Enforcement

The Planning and Development Services Department is also recruiting casual Bylaw Enforcement Officers for vacation and sick-time coverage and for increased enforcement as necessary. The posting closes Sept. 22.

3. **Great Canadian Shoreline Cleanup**

Department: Engineering and Municipal Operations

Summary: Teams from the Great Canadian Shoreline Cleanup will be removing garbage and debris from White Rock's beaches this weekend. Engineering and Municipal Operations, as well as Parking staff will be providing support. Two parking stalls at Finlay and two parking stalls at Bayview will be allocated for the shoreline clean up efforts. The Solid Waste crew will be providing garbage pickup services.

4. Installation and Operation of Online Arsenic Analyzer

Department: Engineering and Municipal Operations (Water Department)

Summary: The City of White Rock is the first in Canada to install the Online Arsenic Analyzer, a new technology. The HACH Arsenic EZ Analyzer 6200 provides online, real-time data to allow the City of White Rock's Water Department to maintain the performance of the Water Treatment Plant.

Sample collection and delivery is costly and requires the delivery of samples to the laboratory in Surrey. The analysis received from the lab takes four working days. The laboratory is closed on Sundays, statuary holidays and long weekends.

The available data from the online analyzer will allow the City to maintain the high performance of the Water Treatment Plant. Plant operation must stay within the Design Objective of having the treated water supplied to the distribution system to be at <0.002 mg/L ($<2 \mu g/L$ or PPB).

• The City of White Rock is the first in Canada to install the Online Arsenic Analyzer,

which is a new technology.

- The available data will allow the City to maintain the high performance of the Water Treatment Plant.
- Sample collection and delivery is costly and requires the delivery of samples to the laboratory in Surrey.
- The analysis received from the lab takes four working days. The laboratory is closed on Sundays, statuary holidays and long weekends.
- The online option greatly reduces the cost of a same-day sample, which costs 200 per cent more when done in the lab.

Summary: The City contributes monthly updates on the progress of facility reopenings throughout the Region to Metrotown Regional District.

6. Update from the Fire Chief on COVID-19

Department: White Rock Fire Rescue

Summary: British Columbia reported a single-day record of 139 new cases of COVID-19 yesterday. The Province is now dealing with the highest ever number of active cases at 1,412. In total, B.C. has recorded 6,830 cases, with nearly 76 per cent of cases recovered. The number of new cases continues to accelerate. Earlier this week, Provincial Health Officer Dr. Bonnie Henry announced the closure of night clubs and banquet halls along with reduced serving hours for liquor in all bars, pubs and restaurants unless full meal service is being

provided.

The province's death toll now stands at 213, an increase of three over the last seven days.

The number of people isolating due to possible exposure has climbed to 3,109. The Province reports 42 people in hospital, with 14 of them in critical care.
