### 4. The registered owner of the property shall understand the following:

- Your signature on this application verifies you acknowledge your obligations as the Prime Contractor under Section 118 of the Worker's Compensation Act
- Your signature on this application acknowledges your agreement with the Terms and Conditions of the Permit
- No tree removal or pruning shall commence without the prior written approval of the Director of Engineering and Municipal Operations
- Applicant shall pay all costs associated with the tree pruning or removal
- Tree care worker shall provide proof of: \$5 million dollars in liability insurance, current City of White Rock business license, Worksafe coverage in good standing, current ISA certification

### Replacement and Retention Tree Information:

- The placement and species of replacement trees must be approved by the City Arborist
- Replacement trees to be planted according to City of White Rock's tree planting specifications
- All security refunds are contingent on the health, number and size of replacement trees being installed, as determined by the City Arborist
- Tree replacement security refunds are contingent on the replacement tree(s) surviving in-ground for a minimum of one year and can be extended by the City Arborist
- Tree replacement security will only be refunded to the Registered Property Owner as it appears on the City Tree Management Permit Application Form
- Retention trees must be protected with an approved tree protection barrier fence during site development and building construction/demolition
- No demolition permit or building permit shall be issued until a tree protection barrier has been installed and approved by City Arborist
- Tree protection barriers must remain intact throughout the construction on the lot
- Tree protection barriers can only be removed with approval from the City Arborist
- No dumping, storage of materials or excavation is permitted within the critical root zone of the protected tree
- Site disturbance within the tree protection zone is prohibited
- Tree protection security will be reviewed and held by the City for a minimum of one
  year after final building approval and can be extended and held by the City until the City
  Arborist is satisfied with the health of the tree
- The City may keep the security deposit if the City determines that any portion of the Tree Management Permit or Bylaw 1831 or Policy 611 has been violated
- The Director of Engineering & Municipal Operations has the final decision on the timing and amount of the release of the security
