INTRODUCTION

The purpose of this corporate report is to appoint members to the Advisory Design Panel, Board of Variance, and Seniors Advisory Committee and to fill vacancies on the Tour de White Rock Committee and the White Rock Sea Festival Committee.

Council Policies – Terms of Reference for each committee are included for reference under appendices as follows:

- Advisory Design Panel Appendix A;
- Board of Variance Appendix B;
- Seniors Advisory Committee Appendix C;
- Tour de White Rock Committee Appendix D;
- White Rock Sea Festival Committee Appendix E; and,
- Council Policy 120 Council Code of Conduct for Committee Members.

Volunteer opportunities for the Board of Variance, White Rock Sea Festival and Tour de White Rock Committee were advertised in the Peace Arch News November 8, 15, and 20 requesting those interested in serving to submit an application. Committee positions were also advertised on the City website and through social media. The deadline for applications was November 22, 2019.

PAST PRACTICE/ POLICY

Committee appointments are discussed by Council in a closed meeting in accordance with Section 90(1)(a) of the *Community Charter* to allow for discussion including personal information about an identifiable individual.

ANALYSIS

Advisory Design Panel

The Advisory Design Panel (ADP) is appointed by Council to advise Council on the quality of the built environment of the City, and specifically to provide comments and suggestions to improve the design quality of new development and redevelopment in the City. The ADP is regulated by the White Rock Planning Procedures Bylaw and the ADP Terms of Reference.

In accordance with the Terms of Reference for the ADP, the membership of the panel will consist of a minimum of six (6) voting members and one (1) non-voting representative from the Business Improvement Association, and City staff as required. Five (5) members were appointed to serve on the Advisory Design Panel in February 2019. The Landscape Architect position on the ADP expired on December 31, 2019.

The British Columbia Society of Landscape Architects has provided one (1) applicant for consideration for the Landscape Architect position on the ADP.

Board of Variance

The Board of Variance (BoV) is a board that adjudicates appeals for minor variances to the Zoning Bylaw, where compliance with the Zoning Bylaw would create an undue hardship. The BoV is established by Bylaw in accordance with the *Local Government Act*. Board of Variance Bylaw No. 1753 states that the BoV will consist of three (3) members appointed by Council for the three (3) year term.

Five (5) community members have applied to serve on the BoV, all of which have noted that they currently live in White Rock. Two (2) of the applicants noted on their application forms that they have previously served on the BoV.

Seniors Advisory Committee

The Seniors Advisory Committee (SAC) will act as a resource to Council regarding long term and short term issues for seniors in the community. SAC will consider and evaluate issues referred from City Council, and will initiate research on matters deemed to be of concern to local seniors.

At the October 21, 2019 Regular Council meeting a recommendation was received from the Seniors Advisory Committee to increase their voting membership from eleven (11) members to twelve (12) members. Council amended this recommendation and requested that membership be increased to thirteen (13) members to alleviate concerns with an even number of members in regard to voting.

Following this, one (1) member from the SAC has resigned. A resignation letter was provided to Corporate Administration. With this resignation there is a total of ten (10) voting members on the committee.

The Council Representative for this Committee requested that a member from Seniors Come Share be invited as one (1) of the additional Committee members.

Personal Information application has been provided for consideration in appendix C.

Council could also appoint two (2) more additional voting members, with a term expiring December 31, 2020, bringing the membership up to thirteen (13) members. In addition, Council could also suggest one (1) applicant to serve as an alternate should one of the selected applicants no longer be available to serve on the Committee and thus saving having to bring this forward again for this circumstance in 2020.

Appointments were made to the SAC at the April 29, 2019 Closed Council meeting. Six (6) community members applied to serve on the SAC that were not selected at the April 29, 2019 Closed Council meeting, five (5) of which have noted that they currently live in White Rock.

Tour de White Rock Committee

The Tour de White Rock (TdWR) Committee will be appointed by City Council to organize, promote and host the Tour de White Rock – a high profile elite caliber cycling event.

Appointments were made to the TdWR Committee at the February 11, 2019 Closed Council meeting. Following these appointments, two (2) members of the Committee have resigned. Resignation letters were provided by the Committee members to Corporate Administration.

In accordance with the Terms of Reference, Council may appoint up to one (1) voting member from the community at large, and one (1) member from the community with expertise in planning and organizing cycling races (race director position), with terms expiring December 31, 2020.

One (1) community member applied to serve on the TdWR following the Committee vacancy posting with experience in planning and organizing cycling races. In addition, four (4) community members applied to serve of the TdWR Committee that were not selected at the February 11, 2019 Closed Council meeting.

White Rock Sea Festival Committee

The White Rock Sea Festival Committee (SFC) will be appointed by City Council to organize, promote and host the White Rock Sea Festival on the BC Day long weekend in August.

Appointments were made to the SFC at the February 11, 2019 Closed Council meeting. Following these appointments one (1) member has resigned. A resignation letter was provided by the Committee member to Corporate Administration.

In accordance with the Terms of Reference, a minimum of nine (9) voting members will be appointed to the Committee. There are currently ten (10) members appointed to the Committee.

Council may wish to appoint one (1) additional member to the SFC, with a term expiring December 31, 2020.

One (1) community member has applied to serve on the SFC. This applicant is a White Rock resident, and has noted that she has served on the Committee in the past.

CONCLUSION

INTRODUCTION


This corporate report is provided for information purposes and contains a summary of legal fee costs and matters.

ANALYSIS

The City utilizes Lidstone and Company Barristers and Solicitors in accordance with a Council motion adopted in September 28, 2015. At that time Council endorsed the law firm of Lidstone and Company Barristers and Solicitors based on the firm's experience working with local government law and their competitive rates. It was understood that there may be circumstances where other specialized legal Counsel would also be contacted when beneficial to the City to utilize a service with more experience in that regard. Human Resources is an example of this as they will utilize other legal firms who have extensive experience in specific labour matters.

For various reasons the City's legal fees have been on the increase. The graph below illustrates legal fees from 2010 up to and including invoices for legal fees that have been received to November 2019. The costs are exclusive of legal fees charged to the water utility in regards to the acquisition (from July 2015 onwards) and water utility operations, as they are not part of the general operating fund.

Legal costs associated with the water utility acquisition, and incurred prior to July 2015, which was the effective date of the Letter of Intent, are included in the general fund operating budget figures as the City did not have a water fund at that time. As additional information, legal costs incurred from July 2015 onwards for the water utility acquisition totaled \$72,021 in 2015, \$8,747 in 2016, and \$39,778 in 2017. There were no further legal costs in regard to the water purchse following 2017. Legal costs related to water utility operations were \$17,874 in 2015, \$8,354 in 2016, \$276 in 2017, none for 2018 and \$6,078 in 2019.



The following table provides a summary of actual legal costs compared to the budget by year. Although there can be significant fluctuations between years, it is noted that there is an increasing trend throughout this period.

The graph below outlines how much of the total legal fee charges are made up with labour matters:



A primary reason for the increased legal fees are the continued trend of receiving more challenges by third parties where it is necessary to acquire legal counsel to ensure the best interests of the City are addressed. Due to this trend staff are also seeking legal advice regarding the creation of many legal documents (bylaws, contracts, land questions, agreements etc.). The Corporate Officer (Director of Corporate Administration) channels legal requests directly to the City's legal counsel, so there is control over matters that are being requested to be reviewed. It is important to note that even if the City did have a legal opinion on a matter previously it may be asked to be reviewed or questioned if it still stands. This is due to court decisions being made frequently that could amend a legal opinion or matters evolve that other aspects need to be explored in order for staff or Council to be assured they have the most up to date information to consider or to relay to the public.

BUDGET IMPLICATIONS

The current city budget (2019) for legal fees was adjusted to \$385,000. Attached as Appendix A to this corporate report is a memo from the City's legal counsel, dated January 6, 2020 written by Don Lidstone that outlines **Legal Privilege**

CONCLUSION

With the exception of legal fees charged relating to labour issues, where an issue in this area can have a high impact on the overall legal budget, some further reasons for the City's legal fees being on the rise has been due to new project opportunities, litigation, rail crossing negotiations and some previously outstanding Freedom of Information matters. Staff are also taking precautions to ensure that the City is adequately protected and many new bylaws, contracts and agreements etc. are being vetted through legal counsel, prior to being presented to Council. This practice is to ensure bylaws / documentation are enforceable and will stand up if challenged and that the best interests of the City are addressed. Due diligence is imperative to ensure the City if they are challenged are safeguarded against someone being able to find a "loop hole" and decisions are made with sound advice as to possible solutions and / or alternatives. If this is not addressed the City can find itself in a situation where they are facing legal challenge(s).
