The Unlocated Record could not be located at the time that this Corporate Report was printed.

Staff would require Council's authorization to release the Closed Meeting Records, the Negotiation Records and the Privileged Record to the public.

The Public Records have been included in this Corporate Report for information. The City must disclose these records (subject to minor mandatory redactions for personal information) because either i) they have previously been disclosed elsewhere, or ii) there are no applicable exceptions to the disclosure requirements in *FIPPA*.

The content of the Un-located Record is currently unknown, but efforts to locate it are ongoing. If it is located, the Un-located Record will be presented on table at the time of the meeting. In such an event, the Director of Corporate Administration may provide additional recommendations for its treatment.

PAST PRACTICE / POLICY / LEGISLATION

Community Charter

Meetings that may or must be closed to the public

- **90** (1) A part of a council meeting may be closed to the public if the subject matter being considered relates to or is one or more of the following:
- $[\ldots]$
- (d) the security of the property of the municipality;
- (e) the acquisition, disposition or expropriation of land or improvements, if the council considers that disclosure could reasonably be expected to harm the interests of the municipality;
- [...]
- (g) litigation or potential litigation affecting the municipality;
- [...]
- (i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- [...]
- (k) negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the council, could reasonably be expected to harm the interests of the municipality if they were held in public;
- [...]

The Closed Meeting Records include content from prior Council meetings held in the absence of the public subject to s. 90 (1)(d)(e)(g)(i) and (k) of the *Community Charter*. Generally, section 12(3)(b) of *FIPPA* provides an exemption to the requirement to disclose this information when responding to an access request.

The Negotiation Records and the Privileged Record contain information that is subject to legal privilege, including solicitor-client privilege and settlement privilege. Section 14 of *FIPPA* and common law rules of privilege provide an exemption to the requirement to disclose this information when responding to an access request.

FIPPA

- 12 (3) The head of a local public body may refuse to disclose to an applicant information that would reveal
- [...]
- (b) the substance of deliberations of a meeting of its elected officials or of its governing body or a committee of its governing body, if an Act or a regulation under this Act authorizes the holding of that meeting in the absence of the public.
- [...]
- 14 The head of a public body may refuse to disclose to an applicant information that is subject to solicitor client privilege.

Council has previously stated a desire for utmost transparency in all City dealings and have indicated a preference that the City avoid discretionary exemptions to the disclosure requirements of *FIPPA*. Staff have no authority to waive confidentiality of closed meeting records or waive legal privilege over records to which it applies. In order for these records to be released, Council must explicitly waive legal privilege and authorize the release of closed meeting records or privileged records.

The City has requested comment from the Semiahmoo First Nation regarding the potential disclosure of the Negotiation Records. Although it does not appear that any of the information should be subject to a *FIPPA* exemption that requires third-party consultation (e.g. harm to third-party business interests), staff have requested consultation as a courtesy. If the Semiahmoo First Nation expresses opposition to the release of any records, staff may still withhold them or bring the information back to Council for further direction.

ANALYSIS

Council has complete discretion as to whether they determine it is in the public interest to authorize the release of the Closed Meeting Records, the Negotiation Records and/or the Privileged Record and the timing of a release. The City has a good legal basis to withhold if Council is of the opinion that release would be detrimental to the interest of the City or its ongoing negotiations where trust building with the Semiahmoo First Nation is a large part of the process.

Comments received from the Semiahmoo First Nation will need to be considered before making a final decision on disclosure.

BUDGET IMPLICATIONS

There are no budget implications associated with this Corporate Report.

OPTIONS

- 1. Council takes no action and the Closed Meeting Records, the Negotiation Records, and the Privileged Record are withheld.
- 2. Council authorizes the release of the Closed Meeting Records, the Negotiation Records, and the Privileged Record by adopting a resolution such as the following:






