Hi Jim,

The project requires archaeological permit from the provincial government, which takes 6-8 months to complete. Currently, we are at the 2-month mark; therefore, the chances of having this project complete by early December is close to nil.

If we can somehow get the archaeological permit from the provincial government by early next week, then we can sole source for contractor and supplier to get the electrical trenching work done by end of November and installing the lights by early December.
