- (c) labour relations or other employee relations;
- (d) the security of the property of the municipality;
- (e) the acquisition, disposition or expropriation of land or improvements, if the council considers that disclosure could reasonably be expected to harm the interests of the municipality;
- (f) law enforcement, if the council considers that disclosure could reasonably be expected to harm the conduct of an investigation under or enforcement of an enactment;
- (g) litigation or potential litigation affecting the municipality;





- (h) an administrative tribunal hearing or potential administrative tribunal hearing affecting the municipality, other than a hearing to be conducted by the council or a delegate of council;
- (i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- (j) information that is prohibited, or information that if it were presented in a document would be prohibited, from disclosure under section 21 of the *Freedom of Information and Protection of Privacy Act*;
- (k) negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the council, could reasonably be expected to harm the interests of the municipality if they were held in public;
- (l) discussions with municipal officers and employees respecting municipal objectives, measures and progress reports for the purposes of preparing an annual report under section 98 [annual municipal report];
- (m) a matter that, under another enactment, is such that the public may be excluded from the meeting;
- (2) A part of a council meeting must be closed to the public if the subject matter being considered relates to one or more of the following:
  - (b) the consideration of information received and held in confidence relating to negotiations between the municipality and a provincial government or the federal government or both, or between a provincial government or the federal government or both and a third party;

Mayor Walker to discuss proposal from the City of Surrey noted at an At-Risk and Vulnerable Task Force Meeting that the City of Surrey would be willing to purchase land within the City of White Rock boundary to house a permanent shelter to serve the South Surrey / White Rock area.

Excerpt from the September 2<sup>nd</sup>, 2021 At-Risk and Vulnerable Task Force meeting:

It was noted that the City of Surrey is still interested in modular housing with the intention to locate land for this in White Rock, which would then be purchased by the City of Surrey. In order to run the shelter, it was noted that BC Housing could work with a non-profit organization. A level of urgency on this project was noted (if it cannot progress quickly in the next few months it may need to wait to be addressed until later next year).

The Chief Administrative Officer from White Rock and City Manager from Surrey will be looking into this, as well as what type of housing (modular, permanent etc.) could be required.

Note: Since receiving this direction staff have added a referral step in the application review process to ensure the Manager of Cultural Services is given the opportunity to comment on planning applications which may host an arts and cultural space / component. In instances where the Manager believes a project lends itself to the incorporation of a public art component they would notify the Planner for discussion with the applicant. As the application is advanced, there would be opportunities to engage members of the Public Art Advisory Committee (PAAC) in a discussion regarding the potential inclusion of arts and cultural space / component into a specific project; ideally before this occurs the proponent, working with the Manager of Cultural Services, has advanced options to be formally presented to PAAC.

Taking this new step into account it is believed that the recommended appointment of PAAC members to the Advisory Design Panel (ADP) is no longer necessary.

### 6. STAFFING LEVELS

The Chief Administrative Officer provided a verbal update.

Staffing challenges and some solutions were provided regarding both the Engineering & Municipal Operations and Planning and Development Services Departments.

The following discussion points were noted:

- Multi Family Solid Waste Collection is a high priority, a Solid Waste Coordinator position is needed to help in providing this service (an amendment to the Financial Plan is required to accommodate this)
- The Manager of Engineering position was not successfully filled and now needs to be re-posted
- Four (4) key positions in Engineering are now vacant and the Director of the department is trying to address the responsibilities
- Committee attendance and the work they generate are of a concern, not able to keep up

- With the Acting Director of Planning and Development Services now giving final notice it was noted the 35+ active applicants in the system will need to be contacted asking for their patience
- Remaining staff in Planning and Development Services are new to the City (not a lot of experience yet in their roles)
- Interviews of possible consultants to help with the Planning Department has been set up for this week
- Streamlining the City's permitting process is something that is on the work list to do, however there needs to be staff to enact this
- Human Resources will be looking to obtain some help with some of the key vacant positions by using an executive search service
