# 2024 Facility Booking - Quick Fact Sheet

- 3. **FACILITY ATTENDANT FEE** applies for any booking outside of Customer Service hours at the White Rock Community Centre, Kent Street Activity Centre and may apply at Centennial Park Leisure Centre.
- 4. **ROOM ACCESS** at time of rental, no early access.

#### 5. **PARKING**

- Centennial Park Leisure Centre: Pay parking is in effect 24 hours a day, 7 days a week.
- Centre For Active Living: Pay parking is in effect 24 hours a day, 7 days a week.
- Kent Street Activity Centre: Free parking with rental.
- White Rock Community Centre: Maximum 4-hour free underground parking.

#### 6. **REFUNDABLE DAMAGE DEPOSIT AND RENTAL FEE**

Damage deposit may be required at the time of booking. The renter must provide a major credit card. We are unable to hold rooms.

- 9. **FRASER HEALTH TEMPORARY FOOD PREMISES PERMIT** not required for private events (i.e. weddings, family reunion). <u>Application Form.</u>

## 10. LIQUOR LICENCE

Apply for permit online orat any Government Liquor Store. Application Form.

#### 11. SETUP

User group may be responsible for setup and takedown during rental time as well as ensuring equipment is compatible prior to event. All rental items (dishes, etc.) must be removed at time that the contract ends. No confetti, open flames (candles must be in hurricane lamps). No tape/decorations adhered to painted walls.

## 12. REFUND POLICY

Cancellations less than 14 calendar days prior to first day of room booking:

- 100% of the fee is charged (no credits available).
- The damage deposit is refunded (no Refund Administration Fee applies)

### 13. INSURANCE

For most City of White Rock facility rentals, you must obtain and provide proof of Commercial General Liability Insurance naming the **Corporation of the City of White Rock** as an "additional insured". You are responsible for obtaining, at your own cost, insurance for a minimum coverage limit for \$2,000,000 - \$5,000,000 depending on the type of booking. Proof of insurance is required upon booking.
