One of the people that was helping with flooding was able to contact the owner of the building and we were able to gain access to the suite above. There was no water in the suite on the 3rd floor. We shut off the water in the mechanical room but this did not shut off the water in the suites. After looking for the water shut off we were unable to find it. I suggested to the workers in Primos that they call a plumber. They had buckets that they were gathering the water in. We then cleared. The renter, Redacted S. 22, of the s. 22 suite called the hall to get information on the flood. When we got back to the hall I spoke to s. 22 and informed s. 22 that we had been in s. 22 suite to check for water leaks but there was no water damage.
