Call for residential alarms at 157202 Goggs st. Arrived on scene nothing showing and set up Command. Knocked on front door several times but no answer. Went around back and up the stairs led by next door neighbor. After knock loud several times the resident answered the door. s.22 would only open it slightly. s.22 said there's nothing burning and don't know why the alarm activated. As s.22 was stalling i could see light smoke coming out of the kitchen. I asked Dispatch to have RCMP attend as it appeared s.22 was not going to let me in. Had our crew lay line to the back as now we could smell it as well. I asked s.22 to let me in to investigate but quickly realized i wouldn't get far. The entire kitchen was full of s.22 items from top to bottom. I managed to make my way to the stove. There was some unknown material that burnt on top of the stove. WE could not investigate rest of the house as it was not possible to get through s.22 storage items. The tic indicated the most heat was on top of the stove. Rest of the room was normal. RCMP arrived on scene. Notified Dispatch to terminate Command an E1 would remain on scene. Few minutes later E1 was able to clear.
