1. That the Water Service, if approved, will be subject to all conditions and limitations in the Corporation of the City of White Rock Water Service Bylaw, 2015, No. 2017, as amended from time to time, including subsequent to the date of the Bylaw;
2. To duly pay all charges, fees and taxes as prescribed by the Bylaw or bylaws of the City pertaining to the supply of water under the Water Service;
3. To release, indemnify and save harmless the City, its elected and appointed officials, employees and agents from and against any and all liability, actions, causes of actions, claims damages, expenses, costs, debts, demands or losses suffered or incurred arising out of the breakdown or malfunction of a water facility, system or the Water Service;
4. To obtain, as applicable, from any purchaser, lessee, tenant or other transferee or occupier of the Property and to deliver to the City, an agreement to be bound by the terms of this Agreement. Provided that this agreement is obtained, then the Customer shall not be liable under any of the covenants and agreements contained herein where such liability arises by reason of an act or omission occurring after the Customer ceases to have any further interest in the Property;
